

A. Introduction

The curriculum of the international program in certain degree, is similar to the curriculum of regular program. Both of the program follow the curriculum base on content stipulated from the Decree of the Rector No: 341/SK-Rek/DA/III/2018 dated 29 March 2018. The new curriculum required student to take at least 147 credits that includes 20 credits of University Mandatory Subjects, 107 credits of Main Mandatory Subjects, 12 credits of Study Programme Mandatory Subjects, and 8 credits Elective Subjects.
